SUPERINTENDENT'S REPORT - Ms. Myrah introduced members of the Peers 4 Peers club led by Ms. Barb Whyte and Mr. Thomas Stuber. Students from the organization gave the school board an overview of peers 4 peers which is a proactive organization whose members serve as a support for their peers that may be experiencing a variety of struggles or just need someone to connect with. Members are selected after an interview process and undergo in person training at WCTC. The club provides a leadership learning experience for its members, as well as offering support for students dealing with challenges including everything from peer pressure to homework to mental health/stress. Board members asked several questions and thanked the students for their work and concern for others.
